1. Motion that no edits or changes be made to the first 164 pages of the book Alcoholics Anonymous because its "main purpose" is "to show other alcoholics precisely how we have recovered."

New Business

2. Motion to propose to the General Service Conference that no more changes be made to the original text wording of the book Twelve Steps and Twelve Traditions, other than periodically updating footnote information, since "...the book has helped so many alcoholics find recovery, there exists strong sentiment within the Fellowship against any change to it. In fact, the 2002 General Service Conference discussed this issue and it was unanimously recommended that: 'The text in the book Twelve Steps and Twelve Traditions, written by Bill W., remain as is, recognizing the Fellowship's feelings that Bill's writing be retained as originally published.' " (Quoted from the book's Introduction.)

3. Motion for Area 27 to create a budget line item for scholarships to provide support to homegroups who request funds to send their GSRs to Area 27. *Motion by Colyn N. on behalf of St. Charles Angels Group.*
